## ORDER

WHEREAS one positive case of COVID-19 was detected in Village Dhakyan, Gram Panchayat Ghangot, Sub Division Barsar, two positive cases in Village Barsar, Gram Panchayat Barsar, Sub Division Barsar, one positive case in Village Bharmoti, Gram Panchayat Bahanwin, Sub Division Bhoranj, one positive case in Village Sargoon Hira, Ward No 08 , Gram Panchayat Karot, Sub Division Sujanpur, two positive cases in Village Darogan, Gram Panchayat Darogan Pati Kot, Sub Division Hamirpur, one positive case in Village Krest, Gram Panchayat, Mati Tihra, Sub Division Hamirpur, one positive case in Village Anu Kalan, Gram Panchayat Anu , Sub Division Hamirpur, one positive case in Village Panjot, Gram Panchayat Panjot, Sub Division Hamirpur, two positive case in Village Upper Gabba and Village Tapre, Gram Panchayat Tapre, Sub Division Hamirpur, three positive cases in Village Maid, Gram Panchayat Pandwin, Sub Division Hamirpur, one positive case in Village Jalari, Gram Panchayat Jalari , Sub Division Nadaun and in order to contain the spread of COVID-19, the following areas of Sub-Division Barsar, Bhoranj, Sujanpur, Hamirpur & Nadaun were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-7901 dated 30/08/2020.
