## ORDER

WHEREAS two positive cases of COVID-19 were detected in Gram Panchayat Sour and Maharal, Sub Division Barsar, four positive cases in Gram Panchayat Bhoranj ,GP Dhamrol and GP –Keharwin, Sub Division Bhoranj, One positive case in Gram Panchayat Laleen , Sub Division Hamirpur, district Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub Division Barsar, Bhoranj & Hamirpur were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-7946 dated 01/09/2020.
