ORDER UNDER SECTION 144 Cr. P.C.

WHEREAS, it has been brought to the notice of the undersigned by the Health Authorities of District Hamirpur that three positive cases of Covid-19 have been detected in the following areas of District Hamirpur HP.

1. One positive case in Village- Jharnot, Gram Panchayat-Morshu Sultani, Sub Division- Barsar
2. One positive case in Village- Bela , Gram Panchayat-Bela , Sub Division- Nadaun.
3. One positive case in Nagar Panchayat- Nadaun, Sub Division –Nadaun.

Thus, there is an imminent risk of spreading of COVID-19 in the surrounding areas which may result in sudden hike in corona cases in the district. Hence, strict measures are the urgent need of the hour to prevent the spreading of this disease which if not taken immediately, can pose grave danger to the lives, health and safety of the residents of the area.

Therefore, keeping in view the aforesaid facts and circumstances , under Section 144 of the Code of Criminal Procedure, do hereby order complete sealing of the areas shown below:

Barsar	Morshu Sultani	Left side of Una-Hamirpur highway road on link road Patera-Jharnot[from the house of Sh. Ramesh Chand to house of Sh. Rakesh Pal] Village- Jharnot {Ward No-01}
Nadaun	Bela	Ward No -03 Village Bela restricted area from Ashok Kumar House to house of Udham Singh and Vijay Kumar Dhiman
	Nagar Panchayat Nadaun	Ward No-01 Village Kot, Nagar Panchayat – Nadaun (Restricted Area left side of old bus stand road Gali No.01 Village kot in front of Rehan Basera from the house of Mehar Chand to House of Rajesh Jassal including with Covid positive persons.)

It is further ordered that under no circumstances ingress/egress of any person or vehicle, except officers/officials/vehicles on Government duty, to this area shall be allowed . Further, now there shall be no relaxation in CURFEW imposed qua any shops or banks within the entire area as described above till further orders. The home delievery of all the essential goods like milk, groceries, fruits, vegetables, pharamceutical, gas supply shall be done through the Administration.

No person shall leave their homes or move on foot or by vehicle or travel or roam around or stand on any road or public place in afore mentioned areas of the respective Panchayats till futher orders.

This order shall come into force with immediate effect.
