ORDER

WHEREAS one positive case of COVID-19 was detected in Gram Panchayat Karsai, Sub Division Barsar, two positive cases in Gram Panchayat Amlehar and GP Behrer, Sub Division Nadaun, One positive case in Municipal Council Sujanpur, Sub Division Sujanpur, district Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub Division Barsar, Nadaun & Sujanpur were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-7952 dated 02/09/2020.

Barsar	Karsai	Left side of Jyoli-Devi to Saheli link road (from house of Sh. Somdutt to house of Smt. Kamla Devi) (6-families) Village Saheli and Ward No. 01
Nadaun	Amlehar	Ward No. 05, Village Bhabran (Area restricted to the Bhabran (Mohal) and Basti near Baba Balak Nath Temple, starting from link road to house of Kalli Dass)
	Behrer	Ward No 05, Village Sukriyah (area restricted to the right side gali near sanjay house to sanjay house)
Sujanpur	MC Area	Ward No. 05, Village Sujanpur, Municipal Council Sujanpur from house of Sh. Sarwan Kumar to Chander Parkash House.

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.

This order shall come into force with immediate effect.
