## ORDER

WHEREAS one positive case of COVID-19 was detected in Village Jasoh , Gram Panchayat Badaran, Sub Division Nadaun, Two positive cases in Village Bhadroon, Gram Panchayat Bhadroon, Sub Division Nadaun, two positive cases in Village Busal, Gram Panchayat Choru, Sub Division Nadaun, six positive cases in Village Jalari Shounkhlian, Gram Panchayat Jalri, Sub Division- Nadaun, one positive case in Village Chambay , Gram Panchayat Giaragram, Sub Divison Barsar, one positive case in Village Dhalakana, Gram Panchayat-Panoh, Sub Division Sujanpur, district Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub Division Sujanpur, Barsar & Nadaun were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-7983 dated 06/09/2020.
