ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 05, Gram Panchayat Dhaned, Sub Divison Hamirpur, one positive case in Ward No. 04, Gram Panchayat Gawardoo, Sub Divison Hamirpur One Positive case in Ward No. 04, MC Area, Sub Divison & District Hamirpur HP, one positive case in Ward No. 03, Gram Panchayat Brahlari, Sub Divison Nadaun, two positive cases in Ward No. 04, Village Garni, Gram Panchayat Kaloer, Sub Divison Nadaun,One Positive case in Ward No. 03, Village Seri, Nagar Panchayat Nadaun, Sub Divison Nadaun, two positive cases in Ward No. 06, Village Guriah Kalan, Gram Panchayat Usnar Kalan & in Ward No. 01, Village Kharotta, Gram Panchayta Kiarabaag, Sub Divison Barsar, District Hamirpur HP and in order to contain the spread of COVID-19, the following areas of Sub Division Hamirpur, Barsar & Nadaun were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-7988 dated 07/09/2020.
