ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 06, Village -Manvi, Gram Panchayat -Manvi, Sub Division-Bhoranj, one positive case in Ward No. 05, Village- Patta, Gram Panchayat- Patta, Sub Division Bhoranj, one positive case in Ward No. 01,Village- Sungrwar, Gram Panchayat-Tikkari Minhansa, Sub Division Bhoranj, one positive case in Ward No. 01, Village-Dungi, Gram Panchayat – Tikkar Bhula, Sub Division Hamirpur , Two positive cases in Ward No. 01, MC Sujanpur, Sub Division Sujanpur and one positive case in Ward No. 01, Village-Badehra, Gram Panchayat – Manjheli, Sub Division Nadaun of District Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub Division Barsar were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-10009 dated 23/09/2020.
