ORDER

WHEREAS three positive cases of COVID-19 were detected in Village-Raily, Gram Panchyat- Raily , Sub Division- Barsar ,Village -Dugga, Gram Panchayat-Dugga,Sub-Division- Hamirpur and Village - Sadoh ,Gram Panchayat- Mansai, Sub Division -Nadaun and in order to contain spread of COVID -19, the following areas were declared as Containment Zone vide Order No- DCH/RELIEF/DMC/2020- 10020 dated 24.09.2020.

Hamirpur	Dugga	<ul style="list-style-type: none">Ward No-06 Village-Dugga(only house of Sh. Rajinder Kumar)
Nadaun	Mansai	<ul style="list-style-type: none">Ward No 04 Village – Sadoh (Restricted area all houses of Village Upper Sadoh with shops (Covid-19 persons)

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign and such Containment of above mentioned areas is not required to be continue as such.

Therefore , do hereby ordered that all the above mentioned areas shall no longer be sealed and hereby **denotified as Containment Zone.**

This order shall come into force with immediate effect.
