

ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 02, Village Baroha, Gram Panchayat Dugha, Sub- Division Hamirpur, two positive cases in Ward No. 05, Vill Jahu Kalan, Gram Panchayat Jahu, Sub Division- Bhoranj and Ward No. 03 Village Bhukkar, Gram Panchayat Bhukkar, Sub Division Bhoranj, three positive cases in Ward No. 04, Village Dhamrol, Gram Panchayat Dhamrol, Sub Division Bhoranj and in Ward No. 04, Village Mundkhar Gainda, Gram Panchayat Mundkhar, Sub Division-Bhoranj & in Ward No. 03, Village- Ladrour Kalan, Gram Panchayat Jharlog, Sub Division Bhoranj and District Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub Division Hamirpur & Bhoranj were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-10193 dated 15/10/2020.

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Debasweta Banik (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.

This order shall come into force with immediate effect.
