ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 3, Village Harsan, Gram Panchayat Narsin, Sub Division Hamirpur, one positive case in Ward No. 7, Village Mundkhar Gainda, Gram Panchayat Mundkhar, Sub Division Bhoranj, one positive case in Ward No. 7, Village Mahal, Gram Panchayat Mahal, Sub Division Bhoranj, two positive cases in Ward No. 2, Village Mansui Manjhali & in Ward No. 7, Village Dain, Gram Panchayat Sour, Sub Division Barsar, District Hamirpur HP and in order to contain the spread of COVID-19, the following areas of Sub Division Hamirpur, Barsar, & Bhoranj were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-10255 dated 23/10/2020.

		Ward No. 7, Village Dain, (Left side of Pundar-Dain link road, house of Sh. Pan Singh only; total population-4)

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Debasweta Banik (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.
