

ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 7, Village Pandhera, Gram Panchayat Mansai, Sub- Division Nadaun, one positive case in Ward No. 4, Village Mohin, Gram Panchayat Balh, Sub Division Hamirpur, one positive case in Ward No.6, Village Jhinkari, Gram Panchayat Pandvi, Sub Division Hamirpur, one positive case in Ward No. 2, Gram Panchayat Mati Tihra, Sub- Division- Hamirpur, One positive case in Village Rangar , Gram Panchayat Rangar , Sub- Division Sujanpur, One positive case in Village Barog , Gram Panchayat Patlander, Sub Division Sujanpur, one positive case in Village-Bassi Hazama, Gram Panchayat Tikkari Minhansa , Sub Division Bhoranj, one positive case in Village- Dungri , Gram Panchayat Sadhrian, Sub Division Bhoranj, one positive case in Village Ropri, Gram Panchayat Dhamrol , Sub-Division Bhoranj, District Hamirpur HP and in order to contain the spread of COVID-19, the following areas of Sub Division Nadaun, Hamirpur, Sujanpur & Bhoranj were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-10301 dated 27/10/2020.
