## ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 02, Village Tapre, Gram Panchayat Tapre, Sub Division Hamirpur, one positive case in Village Ree, Gram Panchayat Ree , Sub Division Sujanpur, two positive cases in Ward No. 03 & in Ward No. 02, Village Seri, Nagar Panchayat Nadaun, Sub Division Nadaun , District Hamirpur HP and in order to contain the spread of COVID-19, the following areas of Sub Division Hamirpur, Sujanpur & Nadaun were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-10371 dated 03/11/2020.

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Debasweta Banik (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.
