## ORDER

WHEREAS nine positive cases of COVID-19 were detected in Ward No. 06, Gram Panchayat Morsu Sultani, Sub Division Barsar, One positive case in Ward No. 04, Gram Panchayat Amroh, Sub Division Hamirpur, One positive case in Ward No. 03, Village Jhaleri, Gram Panchayat Majhog Sultani, Sub Division Hamirpur, Six positive cases in Ward No. 04, Village Bela, Gram Panchayat Bela, Sub Division Nadaun and in order to contain the spread of COVID-19, the following areas of Sub Division Barsar, Hamirpur & Nadaun were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020-10445 dated 06/11/2020.



Hamirpur	Majhog Sultani	Ward No. 03, Village Jhaleri (Ashok Kumar house to Ajay Kumar house; total house-2)
Nadaun	Bela	Ward No. 04, Village Bela (Restricted area left side on way to bachpan school Covid-19 positive house's namely Pardeep Bhatia, Milap Chand, Santosh Kumar, Sanjay Kumar)

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Debasweta Banik (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.

**This order shall come into force with immediate effect.**
