

ORDER

WHEREAS three positive cases of COVID-19 were detected in Ward No. 04, Village Kakkar, Gram Panchayat Kakkar, Sub Division Bhoranj, One positive case in Ward No. 04, Village Kuthera Balli, Gram Panchayat Sareri, Sub Division Nadaun, One positive case in Ward No. 02, Village Kohlwin, Gram Panchayat Sikander, Sub Division Hamirpur, One positive case in Ward No. 05, Gram Panchayat Sasan, Sub Division Hamirpur, Three positive cases in Ward No. 03, Village Lohakhar, Gram Panchayat Gawardoo, Sub Division Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub Division Bhoranj, Hamirpur & Nadaun were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-10483 dated 09/11/2020.

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Debasweta Banik (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.

This order shall come into force with immediate effect.
