## ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 02, Village Dugav Khurd, Gram Panchayat Dugha, Sub Division Hamirpur, One positive case in Ward No. 01, Village Kakaryar ,Gram Panchayat Nadsin, Sub Division Hamirpur, One positive case in Ward No. 03, Village Damui, Gram Panchayat Darin, Sub Division Hamirpur, One positive case in Ward No. 03, Village Lohakhar, Gram Panchayat Gawardoo, Sub Division Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub Division Hamirpur were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-10530 dated 16/11/2020.
