## ORDER UNDER SECTION 144 Cr. P.C.

WHEREAS, it has been brought to the notice of the undersigned by the Health Authorities of District Hamirpur that five positive cases of Covid-19 have been detected in following areas of District Hamirpur HP.

1. One positive case in Ward No.04, Village Gahara, Gram Panchayat – Kala Amb, Sub Division Hamirpur.
2. One positive case in Ward No.05, Village Charian de Dhar, Gram Panchayat – Charian de Dhar, Sub Division Hamirpur.
3. One positive case in Ward No.02, Village Baroha, Gram Panchayat – Dugha, Sub Division Hamirpur.
4. One positive case in Ward No.02, Village Harned, Gram Panchayat – Bafrin, Sub Division Hamirpur.
5. One positive case in Ward No.01, Village Bhamnoh, Gram Panchayat – Dari, Sub Division Hamirpur

Thus, there is an imminent risk of spreading of COVID-19 in the surrounding areas which may result in sudden hike in corona cases in the district. Hence, strict measures are the urgent need of the hour to prevent the spreading of this disease which if not taken immediately, can pose grave danger to the lives, health and safety of the residents of the area.

Therefore, keeping in view the aforesaid facts and circumstances, I, Debasweta Banik (IAS) District Magistrate, Hamirpur (Himachal Pradesh) in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, do hereby order complete sealing of the areas shown below:

	Dari	Ward No.01, Village Bhamnoh (One house of Sh. Rajeev S/o Sh. Ranveer Singh)

It is further ordered that under no circumstances ingress/egress of any person or vehicle, except officers/officials/vehicles on Government duty, to this area shall be allowed. Further, now there shall be no relaxation in CURFEW imposed qua any shops or banks within the entire area as described above till further orders. The home delivery of all the essential goods like milk, groceries, fruits, vegetables, pharmaceutical, gas supply shall be done through the Administration.

No person shall leave their homes or move on foot or by vehicle or travel or roam around or stand on any road or public place in afore mentioned areas of the respective Panchayats till further orders.

**This order shall come into force with immediate effect.**
