ORDER UNDER SECTION 144 Cr. P.C.

WHEREAS, it has been brought to the notice of the undersigned by the Health Authorities of District Hamirpur that seven positive cases of Covid-19 have been detected in following areas of District Hamirpur HP.

1. One positive case in Ward No.01, Village Kuthar, Gram Panchayat- Bharmoti Khurd, Sub Division Nadaun.
2. One positive case in Ward No 7, Village Hatli, Gram Panchayat- Lahra, Sub Division Nadaun.
3. One positive case in Ward No 6, Village Hatli, Gram Panchayat- Lahra, Sub Division Nadaun.
4. One positive case in Ward No 3, Vill Kitpal, Gram Panchayat- Kitpal, Sub Division Nadaun.
5. One positive case in Ward No-04, Vill Gurehad, Gram Panchayat- Kohla, Sub Division Nadaun.
6. One positive case in Ward No-02, Vill Batnari, Gram Panchayat- Uttap, Sub Division Nadaun.
7. One positive case in Ward No-07, Village Karohta, Gram Panchayat- Karohta, Sub Division Bhoranj.

Thus, there is an imminent risk of spreading of COVID-19 in the surrounding areas which may result in sudden hike in corona cases in the district. Hence, strict measures are the urgent need of the hour to prevent the spreading of this disease which if not taken immediately, can pose grave danger to the lives, health and safety of the residents of the area.

Therefore, keeping in view the aforesaid facts and circumstances, under Section 144 of the Code of Criminal Procedure, do hereby order complete sealing of the areas shown below:

	Kitpal	Ward No 3, Vill Kitpal; Restricted area near Link road left side pankaj gautam house
	Kohla	Ward No-04, Vill Gurehad; Gori Restricted area left side on way to NH Kohla road to GHS Kohla to site, NH to Kamlesh Kumari house Vill Gurehad
	Uttap	Ward No-02, Vill Batnari; restricted area near from Galore left side to Som Raj House
Bhoranj	Karohta	Ward No-07, Village Karohta; House of Smt Anjana Kumari W/O Atul Katna

It is further ordered that under no circumstances ingress/egress of any person or vehicle, except officers/officials/ in Government duty, to this area shall be allowed. Further, now there shall be no relaxation in the order imposed qua any shops or banks within the entire area as described above till further orders. Some delivery of all the essential goods like milk, groceries, fruits, vegetables, pharmaceutical, etc. shall be done through the Administration.

No person shall leave their homes or move on foot or by vehicle or travel or roam around or stand on any road or public place in afore mentioned areas of the respective Panchayats till further orders.

This order shall come into force with immediate effect.
