## ORDER

WHEREAS One positive case of Covid -19 was detected in in Ward No.07, Village Jharlog Buhla, Gram Panchayat - Jharlog, Sub Division Bhoranj , One positive case in Ward No.01, Village Kot, Nagar Panchayat Area, Sub Division Nadaun and in order to contain the spread of COVID-19, the following areas of Sub Division Nadaun and Bhoranj were declared as Containment Zone vide Order No. DCH/RELIEF/DMC/2020/-10670 dated 26/11/2020.

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Debasweta Banik (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.
