TENDER NOTICE-CUM OPEN AUCTION

Office of the SDO(C) Sujanpur-cum-mela officer, National Holi Fair Committee Sujanpur intends to invite sealed tenders for "Letting out space in Chaugan at Sujanpur Town for setting up of Domes/Zulla and sanitation during National Holi festival 2021" scheduled to be organized w.e.f. 26.03.2021 to 29.03.2021 from experienced and registered vendors/event managers having turnover not less than Rs. 15 Lakhs (Fifty Lakhs) per annum during last three years. For sanitation the turnover should not be less than 6 Lakhs.

Such vendors who fulfill the aforesaid criteria can obtain detailed tender documents from the office of Mela Officer SDO (C) Sujanpur, National Holi Festival Committee, Sujanpur, Distt Hamirpur (HP) on cash payment of Rs. 1,000/- (One Thousand only) on any working day. The tender documents duly filled in all respect must reach in the office of SDO(C) Sujanpur latest by 12th March, 2021 by 12:00 PM (Noon). Any tender, which is received after due date and time shall not be considered. The financial bid must be submitted with the tender document only on the prescribed format and envelope attached with the tender document. The tender shall be opened on same day before appropriate committee.

The tenderer will furnish the financial bids only in the prescribed format and submit the same in the prescribed envelope.

Open auction will be carried out for Dome I and thereafter the sealed cover for this block will be opened and the rates quoted in open auction or in the financial bid, whichever is higher, will be considered. The same process will be followed for remaining Dome. Only those tenderers can participate in open auction for a particular block or all blocks as a whole, who have submitted their bids for the same, as the case may be, if someone deliberately participates in the open auction without furnishing rates in sealed cover, his earnest money deposit (EMD) will be forfeited.



The tender/contract to the successful bidder/bidders may be awarded Dome wise collectively, whichever will be viable, keeping in view the rates arrived at by way of highest bid/auction.

SDO(C)-Cum-Mela officer National Holi Fair Committee Sujanpur reserves the right to cancel the tender at any time without assigning any reason for the same.
