Notice inviting Limited Tender/Quotations

Sealed tender/quotations are hereby invited from the eligible firms/ Proprietary concerned /agencies for the **Light & Sound System** for the celebration of National Level Holi Utsav – 2021 being celebrated w.e.f. 26.03.2021 to 29.03.2021 on two bid system i.e. **“Technical bid”** and **“ Financial bid”** . Both the bids must be kept in separate envelopes super scribed **“Technical bid”** and **“Financial bid”**. Both the envelopes must be kept in a separate envelope super scribed as **“Bid for Light and Sound system”**. The tender/quotations should reach in this office on or before 17.03.2021 at 12.10 PM , if submitted through post or dropped in drop box which is placed in the office of Additional District Magistrate Hamirpur and will be opened on the same day at 12.30 PM in the office of Additional Deputy Commissioner Hamirpur by the committee constituted vide office order No.HMR/DCH/DN/ 354-68 dated 03 .03.2021 for this purpose.

Technical bid requirements:-

1. The participants should have to submit the photocopy of their PAN CARD & GST Number, Income Tax Returns of last two years , otherwise bids will not be entertained. No bid will be accepted unless & until all the documents are properly signed.
2. The participants must have wide experience in the field of installation/providing light & sound in International Level Utsav, National Level Utsav & State Level Utsav for three years (Copy to be attached).Copy of Experience certificate duly issued by the concerned competent authority must be enclosed with the tender.
3. All interested participants will have to furnish an FDR/Demand Draft of Rs. 50,000/- as Earnest Money Deposit (EMD) duly pledged in the name of Deputy Commissioner cum chairman National Level Holi Utsav Committee, Hamirpur which will be converted into performance security, if the bidder is declared qualified for award of the contract. In case of failure in performances, the amount shall be forfeited. Besides other penal provisions as per terms & conditions, attached herewith. The DC cum Chairman National Level Holi Utsav reserves every right with regard to performance security and his decision shall be treated full and final .
4. List of instruments with brand name must be enclosed with the technical bid .

Terms & Conditions:-

1. The Sound/Light will be installed up to 40 KW with digital mixture.
2. Financial bid will be opened only in respect of only those firms who will qualify in technical bid.
3. The participants whose rates will be accepted will have to execute an agreement with the Additional Distt. Magistrate, Hamirpur to the effect that the light/sound shall be provided on the schedule date and Time. On failure to do so, the concerned party shall be liable to pay double the amount fixed to the Utsav Committee as penalty and bank draft/ FDR kept as performance security will also stand forfeited.
4. Applicable TDS on GST & Income Tax Act shall be deducted while making payments to the contractor finally selected. No advance payment under any circumstances shall be made to the contractor.
5. DC Cum Chairman National Level Holi Utsav reserves the right to reject any tender/ rates without assigning any reasons thereof .
