ORDER UNDER SECTION 144 Cr.P.C.



WHEREAS, it has been brought to the notice of the undersigned by the Health Authorities of District Hamirpur that the positive cases of COVID-19 have been detected in this Sub Division.

WHEREAS, there is an imminent risk of spreading COVID-19 in the surrounding detected area, which may cause sudden hike of corona cases in this Sub Division. The strict measures are to be required to prevent the spreading of virus in the area, which if not taken immediately may cause danger to health and safety of the human lives of the area.

Therefore in compliance to office order issued by the District Magistrate, District Hamirpur vide No. DCH/DM Cell/Covid/Containment-2020-10804 dated 09.12.2020, I Dr. Charanji Lal, HPAS, Sub Divisional Magistrate, Sub Division Hamirpur, in exercise of the power vested in me under section 144 of the Code of Criminal Procedure, do hereby order to complete sealing the area shown in following zones:


