

ORDER UNDER SECTION 144 Cr.P.C.



WHEREAS, the positive cases of COVID-19 had been detected in this Sub Division and in order to contain the spread of COVID-19, the following areas were declared containment zone vide this officer order No. SDH/CZ/2021-5304-5319, 5320-5335 dated 10-10-2021 and 11-10-2021 respectively:-


