**ORDER UNDER SECTION 144 Cr.P.C.**

**WHEREAS**, it has been brought to the notice of the undersigned by the Health Authorities of District Hamirpur that the positive cases of COVID-19 have been detected in this Sub Division.

**WHEREAS**, there is an imminent risk of spreading COVID-19 in the surrounding detected area, which may cause sudden hike of corona cases in this Sub Division. The strict measures are to be required to prevent the spreading of virus in the area, which if not taken immediately may cause danger to health and safety of the human lives of the area.

Therefore in compliance to office order issued by the District Magistrate, District Hamirpur vide No. DCH/DM Cell/Covid/Containment-2020-10804 dated 09.12.2020, I Dr. Charanji Lal, HPAS, Sub Divisional Magistrate, Sub Division Hamirpur, in exercise of the power vested in me under section 144 of the Code of Criminal Procedure, do hereby order to complete sealing the area shown in following zones:

It is further ordered that under no circumstances ingress/egress any person or vehicle, except the officers/officials vehicles on Government duty shall be allowed in the above notified areas.

Further, there shall be no relaxation in curfew imposed qua any shops or banks within the entire above notified area till further orders. The home delivery of all the essentials goods like milk, groceries, vegetables, pharmaceutical, gas supply shall be done through the administration.

No person shall leave their homes or move on foot or by vehicles or travel or roam around or stand on any road or public places in the above referred notified area of the respective Gram Panchayat/MC ward till further orders.

**This order shall come into force with immediate effect.**



WHEREAS, it has been brought to the notice of the undersigned by the Block Medical Officer Barsar of District Hamirpur that Eight (8) positive cases of COVID-19 have been detected on dated 02-11-2021 in the following areas of Sub-Division Barsar, District Hamirpur (HP).

Thus, there is an imminent risk of spreading of COVID-19 in the surrounding areas which may result in sudden hike in corona cases in the district. Hence, strict measures are the urgent need, of the hour to prevent the spreading of this disease which if not taken immediately, can pose grave danger to the lives, health and safety of the residents of the area.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed under section 144 of the Code of Criminal Procedure, 1973.

And therefore, in view of the above circumstances and as per the recommendations of Block Medical Officer Barsar, Dist. Hamirpur as conveyed vide his office letter No.Nil dated 26-10-2021, 27-10-2021 & 28-10-2021 as a containment measure I, Shashi Pal Sharma, HPAS, Sub-Divisional Magistrate, Barsar District-Hamirpur (Himachal Pradesh) in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby order and direct the complete sealing of the areas of Containment zone in the following manner:-


It is further ordered that:

1. UNDER NO CIRCUMSTANCES SHALL THERE BE ANY INGRESS/ EGRESS OF ANY PERSON OR VEHICLE in the containment zone except for persons/vehicles involved in the enforcement of containment plan, medical emergency.
2. The supplies of essential goods like milk, groceries, fruits, vegetables, medicine, cooking gas etc. in the above mentioned containment zone shall be made through the Govt. delivery committee, headed by Pradhan of the Gram Panchayat.
3. No person in the containment zone shall leave their homes on foot or through vehicle or travel or move around, roam around or stand on any public path or place in the aforementioned area.

This order shall come into effect immediately and shall remain in force till further orders.

Any violation of this order will attract provisions of Section 188 Indian Penal Code and the violator can also be prosecuted U/s 269 and 270 of Indian Penal Code.
