ORDER UNDER SECTION-144 Cr.PC.

WHEREAS, it has been brought to the notice of the undersigned by the Block Medical Officer Barsar of District Hamirpur that Sixteen (16) positive cases of COVID-19 have been detected on dated 29-10-2021, 30-10-2021 & 01-11-2021 in the following areas of Sub-Division Barsar, District Hamirpur (HP).

Thus, there is an imminent risk of spreading of COVID-19 in the surrounding areas which may result in sudden hike in corona cases in the district. Hence, strict measures are the urgent need of the hour to prevent the spreading of this disease which if not taken immediately, can pose grave danger to the lives, health and safety of the residents of the area.


Whereas, it is the case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed under section 144 of the Code of Criminal Procedure, 1973.

And therefore, in view of the above circumstances and as per the recommendations of Block Medical Officer Barsar, Distt. Hamirpur as conveyed vide his office letter No.Nil dated 26-10-2021, 27-10-2021 & 28-10-2021 as a containment measure I, Shashi Pal Sharma, HPAS, Sub-Divisional Magistrate, Barsar District-Hamirpur (Himachal Pradesh) in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby order and direct the complete sealing of the areas of Containment zone in the following manner:-

It is further ordered that:

1. UNDER NO CIRCUMSTANCES SHALL THERE BE ANY INGRESS/ EGRESS OF ANY PERSON OR VEHICLE in the containment zone except for persons/vehicles involved in the enforcement of containment plan, medical emergency.
2. The supplies of essential goods like milk, groceries, fruits, vegetables, medicine, cooking gas etc. in the above mentioned containment zone shall be made through the Govt. delivery committee, headed by Pradhan of the Gram Panchayat.
3. No person in the containment zone shall leave their homes on foot or through vehicle or travel or move around, roam around or stand on any public path or place in the aforementioned area.

This order shall come into effect immediately and shall remain in force till further orders.

Any violation of this order will attract provisions of Section 188 Indian Penal Code and the violator can also be prosecuted U/s 269 and 270 of Indian Penal Code.
