1. Sealed Quotations are invited for disposal of the aforesaid vehicle from interested firms/ persons. The vehicle will be sold on "As is where is basis".  
The auction of the vehicle will be conducted by an auction committee of this office.
2. Firms/ persons interested to buy the aforesaid vehicle are required to submit their quotation in enclosed proforma addressed to the CT & GST Officer, Enforcement Unit, Angul-759122, Odisha situated at 3<sup>rd</sup> floor, O/o the CT & GST Territorial Range, Angul .
3. Intending quotationers may inspect the condemned unserviceable vehicle in the office premises on any working day from 30.08.2018 to 10.09.2018 during 10.00 A.M. to 5.00 P.M. after taking due permission.
4. The details of quotation papers are to be sold along with terms and conditions and the quotation schedule can be obtained from the office of the CT & GST Enforcement Unit, Angul during office hours on any working day from 30.08.2018 to 10.09.2018 upto 5 P.M on payment of Rs.200.00 (Rupees Two hundred only) which is non-refundable. The quotationers who desire to submit the quotation by

downloading quotation paper from the website [www.angul.nic.in](http://www.angul.nic.in) is required to submit a Demand Draft of Rs.200.00 (Rupees Two hundred only )towards the cost of tender paper drawn in favour of CT & GST Officer, Enforcement Unit, Angul payable at Angul which is non-refundable.


5. The quotationers may submit their quotation along with EMD (Earnest Money Deposit) of Rs.5000.00 ( Rupees Five thousand only) in shape of Bank Braft drawn in favour of the CT & GST Officer, Enforcement Unit, Angul payable at Angul which shall be subject to refund except in case of highest offer accepted by the competent authority.
6. The quotation paper duly filled in and signed in each page will be received in this office in a sealed envelope superscribed with "Auction Sale Notice No.01/ 2018-19/ Angul" in capital letters addressed to the CT & GST Officer, Enforcement Unit, Angul, which should contain the complete mailing address of the quotationer including contact no., if any. The sealed quotation must be submitted by registered post/ speed post only so as to reach the office on or before 10.09.2018 by 5.00 PM. The date of opening of quotations is 11.09.2018 at 11.30 A.M. The quotation paper received without demand draft of Rs.200.00 (Rupees Two hundred only) towards cost of tender paper in case of downloaded form & EMD beyond due date shall not be entertained. The intending quotationer shall take adequate precaution for timely receipt of the quotation paper complete in all respect. The quotations received in time will be opened in the office chamber of the CT & GST Officer, Enforcement Unit, Angul at 11.30 A.M. on 11.09.2018 in presence of the members of the auction committee and bidders or their representatives (not more than one). If that day be declared as Govt. holiday, then the tender will be opened in the next working day as per the scheduled time.
7. The vehicle will be disposed off "As is where is basis" along with outstanding road tax liability, if any to be paid by the successful bidder. No pending road tax will be paid by this office.
8. The bidder who has quoted the highest price and above the reserved price as fixed by the competent authority, will be considered as the successful bidder for the purpose of this auction.

9. The successful bidder shall have to deposit 25% of the offer amount of the vehicle as soon as the bid is over and the rest amount within 07 (seven) days from the date of approval of the tender. If he fails to deposit the bid amount within the stipulated period, the deposits including the earnest money shall be forfeited. The vehicle shall not be delivered until after full payment and compliance with all requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.
10. If the highest bidder does not accept the offer of sale of vehicle for any reason whatsoever it may be, and withdraws from the bidding, the EMD deposited by such bidder will be forfeited. The second highest bid amount may be considered for sale, if accepted by the competent authority and accordingly, the second highest bid amount will be considered as the highest bid amount or respective vehicle may once again be taken up for re-auction on the same day. If the minimum price is not available by the sealed tender the competent authority may dispose the vehicle through negotiation at a price not less than the highest price offered by the highest tenderer.
11. The vehicle will be delivered only after the receipt of full payment and has to be lifted within 07(Seven) days of the completion of the deal failing which ground rent @ Rs. 200.00 per day will be charged. If ground rent so charged exceeds the sale price deposited, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent and the vehicle becomes absolute property of the CT & GST Officer, Enforcement Unit, Angul.
12. The person authorized by the bidder will be allowed to take the delivery. The bidders are required to produce any of the documents as documentary evidence for proof of their address.
13. This office will not owe any responsibility for transfer of vehicle and for any other liability for using this vehicle for commercial or any other purpose after sale.
14. Once the release order issued, the office will not be responsible either for safe custody or for any loss or damage to the subject vehicle
15. The highest bid once accepted will not be transferable to anyone. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.

16. The decision of the auction committee for all the purposes shall be final and binding.


17. The competent authority reserves the right to reject any or all the tenders without assigning any reasons thereof. The authority also reserves the right to withdraw the said vehicle from the tender/ auction without assigning any reason thereof. The decision of the committee will be final in this regard during the process of tender -cum-sale at any stage.
