### TERMS & CONDITION FOR HIRING OF VEHICLE

- 1- The vehicle during the period of contract shall have all necessary valid M.V documents such as -Valid Registration Certificate, Insurance Certificate, Fitness Certificate, Carriage Contract Permit, Driving license.
- 2- The vehicle shall not be more than 3 years old and also in good running condition.
- 3- The vehicle shall report for minimum 25 days in a month.
- 4- The hire charges will be paid on monthly basis is final and the fuel cost will be paid on actual consumption in a month.
- 5- The maintenance cost of the vehicle & the salary of the driver will be borne by the owner.
- 6- In case replacement of a vehicle is required for the reason maintenance or whatsoever, then a same or better model of vehicle shall be provided by the owner.
- 7- The office shall not be responsible for any damage/loss caused by the hired vehicle or loss of life /injury made to any person or damaged to any property on account of the vehicle any manner whatsoever .and the owner shall be responsible for such litigation.
- 8- In case of emergency, the vehicle will be engaged on duty and no extra-payment shall be demanded.
- 9- If the services are found to be unsatisfactory, the client shall given one month notice and terminate the agreement.
