Whereas, the Government vide their Order, **G.O.(Ms) No.152, Health and Family Welfare (P1) Department, dated: 23.03.2020**, have ordered certain restrictions imposed in the territorial jurisdiction of the State of Tamil Nadu from **18.00 hrs of 24.03.2020 to 06.00 hrs of 01.04.2020** under section (2) of Epidemic Disease Act, 1897. Further, the Government vide **G.O. (Ms) No.172 Revenue and Disaster Management Department, Disaster Management Wing, DM II Section, dated: 25.03.2020** have extended the above restriction up to **14.04.2020**. In addition, the Government vide **G.O. (Ms) No.193 Revenue and Disaster Management Department, Disaster Management Wing, DM II Section, dated: 15.04.2020** have further extended the above restriction up to **03.05.2020**. Further, the Government vide **G.O. (Ms) No.217 Revenue and Disaster Management Department, Disaster Management Wing, DM II Section, dated: 03.05.2020** have further extended the above restriction up to **24.00 hrs of 17.05.2020**. Now, the Government in **Public (S.C) Department vide letter CSCR/130-216/2020, dated: 17.05.2020** have further extended the above restriction up to **24.00 hrs of 31.05.2020** with certain relaxations.

Whereas, it has been noticed that there is imminent possibility to mitigate the spread of **COVID-19** in Tiruchirappalli District, the following prohibitory orders to maintain public health, public safety and public order is absolutely necessary.

- ❖ **Any congregation of more than 05 (five) persons in public place is prohibited.**
- ❖ **People are required to stay at home and come out only for accessing basic an essential services and strictly follow social distancing norms detailed in Government Order mentioned above and maintain a distance of 01 meter or 03 feet norms.**
- ❖ **All suspected cases and foreign returnees, who arrived after 1st March, 2020 are directed to remain under strict home quarantine for such period as decided by local Health Authorities.**
- ❖ **Public transport services including operation of private buses, stage / contract carriages, State Transport Undertakings, Metro services, taxis, share-autos, auto-rickshaws and ride sharing services including air-conditioned bus services of State Transport Corporation and private operators **will not be permitted**, except the categories indicated in the Government Orders mentioned above.**

- ❖ All Inter-district services shall not be operated without TN e-pass.
- ❖ However, establishments notified under list of exempt services / activities in the Government Orders referred shall be exempt from the above restrictions.

And whereas, emergent circumstances do not admit the service of notice to the parties concerned necessitating this order to be passed ex-parte as per the provision laid down u/s 144 (2) Cr.P.C.

Now, therefore, with a view to curtail the spread of COVID-19 and to maintain public health, public safety and public order in Tiruchirappalli District, I do hereby promulgate order u/s 144 Criminal Procedure Code, 1973 prohibiting any congregation of more than 05 (five) persons in public place, in Tiruchirappalli District including Tiruchirappalli city police limit.

The Prohibitory Order of the District Collector, Tiruchirappalli vide Rc.No. D3/100/2020, dated: 03.05.2020 has been further extended up to 24.00 hrs of 31.05.2020.
