Minutes of the District Environmental Plan Committee meeting held at District Collector's chamber on 09.10.2019 at 4.00 P.M. conducted by District Revenue Officer, Dindigul. In this meeting the following members were presented.

The District Revenue Officer, Dindigul has convened the meeting and reviewed the works carried out the local body and other departments towards implementation of various waste management.

The Commissioner, Dindigul Corporation informed that 100 % Door to Door collection with segregation was adopted in the Corporation. The Corporation is constructing micro compost centres and expected to be completed by November 2019. After completion, entire compostable wastes are converted into manure.

In Kodaikanal, door to door collection with segregation is carried out in all wards. 60% of Biodegradable waste is converted into manure. In palani municipality, entire area is covered under door to door collection of solid waste. 89% of wet waste is converted into manure.

In Town panchayats except Ayyalur and Kannivadi i.e. in hilly area 100 % door to door collection with segregation is adopted. The District Revenue Officer instructed to identify the land for composting. All local bodies are instructed to identify site for processing the construction & demolition wastes.

Hon'ble NGT has issued orders in O.A.No.710-713/2017 dated: 15.07.2019 to levy fine for non compliance of orders. In this regard, all local bodies shall provide Sewage Treatment Plant (STP) to treat and dispose the sewage generated in their jurisdiction. Necessary STP proposals shall be formulated.

The District Revenue Officer instructed Joint Director (Health Services) to furnish list of Ayush hospitals and instructed them to obtain BMW Authorization. While inspection of clinics, Hospitals etc under clinical establishment Act, they shall be insisted to have valid BMW Authorization.

The Chief Educational Officer informed that chain of awareness programme are carried out in all schools of Dindigul District from 14.10.2019. Students are educated to segregat the wastes at source itself.

The District Revenue Officer suggested to have inspection of plastic industries for banned plastic production.

At the end of the following decisions were arrived

- All the local bodies shall achieve 100% door to door collection of solid waste and segregated biodegradable wastes shall be converted into manure.
- 2. All the local bodies shall identify site for processing the construction & demolition wastes.
- All local bodies shall provide Sewage Treatment Plant (STP) to treat and dispose the sewage generated in their jurisdiction and necessary STP proposals shall be formulated.

- 4. Joint Director (Health Services) shall furnish list of Ayush hospitals and instruct them to obtain BMW Authorization.
- 5. Joint Director (Health Services) shall insist Clinics, Hospitals etc to have valid BMW Authorization during inspection with respect to Clinical Establishment Act.
- 6. District Environmental Engineer, TNPC Board shall carryout the surprise inspection of plastic units to check whether the banned plastic products are manufactured and take necessary action against defaulting plastic units.
- 7. The Chief Educational Officer shall instruct the schools to create awareness programmes among the students on various waste management.
