- External modification of vehicle(s) to be used in the concerned event, including fitting of loudspeakers thereon, is subject to provisions of the Motor Vehicles Act and the rules framed thereunder. Necessary permission, wherever required, shall be obtained from the competent authority under the said act.
- This permit shall be valid in the areas falling within the revenue district of Imphal West only.
