- All instructions of the Election Commission of India/ CEO, Manipur / District Election Officer/ Returning Officer or any other competent authority under the election machinery with respect to observance of the Model Code of Conduct shall be observed in letter and spirit.
- All instructions of the Election Commission of India or any other competent authority under the election machinery with respect to observance of the norms for incurring election expenses shall be observed in letter and spirit.
- External modification of vehicle(s) to be used in the concerned event, including fitting of loudspeakers thereon, is subject to provisions of the Motor Vehicles Act and the rules framed hereunder. Necessary permission, wherever required, shall be obtained from the competent authority under the said act.
- This permit shall be valid within the areas falling within the revenue district of Imphal West only.
