**NO.DM(IW)/1/669/CON/98:** In pursuance of application dated 4<sup>th</sup> April 2019 received from Shri Soibam Ranbir Singh subject to the provision of the Manipur Control of Use/Play of Loud Speaker Act, 1967 as in force in the state of Manipur, and in relaxation of prohibitory orders dated 11<sup>th</sup> March 2019 imposing restrictions on assembly of persons, etc. issued under Section 144 of CrPC 1973 in Cril. Misc. Case No. 13 of 2019, permission is hereby accorded to the following applicant (at Para 2) for the following activity/activities, the details of which are at para 3: (i) Holding of publicity with using loudspeakers;

2. Name of the applicant: Shri Soibam Ranbir Singh Executive Member, BJP Mandal, 21-Naoriya Pakhanglakpa AC, 1-Inner Manipur Parliamentary Constituency.

3. The events in detail are as follows:

4. This permit is issued on the following terms and conditions:

- a) This permit cannot be used for holding public meetings by blocking National Highway/State Highway/District Road/public thoroughfare.
- b) Where the permit includes use of loud speaker, the loudspeaker(s) shall not be used in any area falling within the Silent Zone.
- c) Where the permit includes use of loud speaker, the permit is only for use of loud speaker(s) at very low volume, notwithstanding that the place of use falls outside the hypersensitive zone.
- d) The permit shall be kept by the permit holder at the place of use of the loud speaker or displayed prominently in original on the vehicle on which the loudspeaker is to be fitted.
- e) The permit holder shall intimate the Officer-in-Charge of the concerned police station and extend full cooperation to the police administration.
- f) The permit shall be produced on demand by any police officer not below the rank of ASI. No sloganeering/ festoon/ placard with communal or anti-national expressions or words shall be used.
- g) Under no circumstances shall a place of worship be used as a forum for election propaganda.
- h) The general public shall in no way be inconvenienced by the conduct of the event.
- i) No traffic regulation shall be violated by the organizers of the event.
- j) The permit holder shall ensure that the flow of traffic is not hampered by the conduct of the event and shall make necessary arrangements accordingly.
- k) The validity of the permit, including the terms and condition may be modified or cancelled by the issuing authority for maintenance of law and order or for any valid reason without serving prior notice to the applicant.
- l) The applicant shall obtain No Objection Certificate in written from the owners/authorities of the building/property/ land where the event is to be organized. A copy thereof indicating the details of the event shall be submitted to the Returning Officer of the bye election within 3 days of the event.

- m) All instructions of the Election Commission of India/ CEO, Manipur / District Election Officer/ Returning Officer or any other competent authority under the election machinery with respect to observance of the Model Code of Conduct shall be observed in letter and spirit.
- n) All instructions of the Election Commission of India or any other competent authority under the election machinery with respect to observance of the norms for incurring election expenses shall be observed in letter and spirit.
- o) External modification of vehicle(s) to be used in the concerned event, including fitting of loudspeakers thereon, is subject to provisions of the Motor Vehicles Act and the rules framed hereunder. Necessary permission, wherever required, shall be obtained from the competent authority under the said act.
- p) Violation of any law in the conduct of the event shall be deemed to be a violation by the contesting/ nominated candidate, notwithstanding that the permit may be issued to an individual, different from the candidate, as at para 2 above.
