(IW)/1/CON/361/02: Whereas, it has been reported that 2 (two) residents of Sagolband Sayang, Imphal West District, are tested COVID-19 positive and in view of the impending threat of COVID-19 pandemic in the area, it has become expedient to issue containment measures to prevent the spread of the disease in the area;

Now, therefore, I, Naorem Praveen Singh, Deputy Commissioner of Imphal West District, Manipur, in exercise of the powers conferred upon me under Para 12 of "The Manipur Epidemic Diseases, COVID – 19 Regulations, 2020" and in pursuance of the advisory of the Director General of Health Services (EMR Division), Ministry of Health and Family Welfare, Government of India in regard to containment of COVID – 19, do hereby declare the following containment measures in the geographical area mentioned in the schedule with immediate effect:

1) Sealing of the geographical area.

2) Entry and exit of population from the containment area.

3) Closure of schools, offices, if any and banning public gathering of any type.

4) Banning vehicular movement in the area.

5) Initiating active surveillance of COVID – 19 cases.

6) Compulsory use of AarogyaSetu application by all the people staying/residing within the containment area.

SCHEDULE

North : Residential plot of Sukham Khelchandra South : Residential plot of Sukham Ingocha East : Residential plot of Sukham Modhusudon

West : Approach road

*NB : The Plots/Road mentioned above indicates the boundaries of the containment zone and in no case are included within the containment zone.

Further, the geographical area lying within a radius of 150 metre beyond the containment zone/area as per schedule aforementioned is identified as the Buffer Zone and the following measures are being adopted in order to effectively break the chain of transmission of the disease:

> Extensive surveillance and contact tracing of the positive cases 1)

2) Reporting clinically suspect cases on COVID-19 on real time basis

Clinical management of confirmed cases. 3)

Sensitization of the local residents on personal hygiene, physical distancing and other preventive measures

Any person/institution/organization found violating any of the above mentioned measures shall be deemed to have committed an offence punishable under Section 188 of the Indian Penal Code, 1860.
