

The nomination papers shall be delivered to the Presiding Officer/Deputy Commissioner, Imphal West as per Rules, i.e. para 3 of Notice under Form-27 circulated to all concerned along with this Notice. If the said election is required, it shall be held immediately after the publication of the list of the Contesting candidates on the day. Notice vide form-27 of the Manipur Panchayati Raj (Election) Rules, 1995 have been issued separately for each of the **14(fourteen)** Members of the Imphal West Zilla Parishad.
