

IN THE COURT OF THE DISTRICT MAGISTRATE: IMPHAL WEST DISTRICT
CRIL MISC CASE NO. 9 of 2021

ORDERS UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Imphal, the 4th August, 2021

Whereas, the prevalence of Delta Variant of Covid-19 in Manipur is quite high and also there is still high detection of the COVID-19 infections daily in the District, which is a cause of great concern and requires stringent measures to reduce the rate of transmission as well as break the chain of transmission of the infectious Virus in the interest of public health;

Whereas, the unwanted death due to Covid -19 still persists and that the compliance level of Covid Appropriate Behaviour by the general public is found unsatisfactory and thereby the prevalence of the high COVID-19 positive cases;

Whereas, adoption of immediate preventive and precautionary measures to strictly enforce the provisions of 'the Manipur Epidemic Diseases (Enforcement of COVID-19 Guidelines) Regulation, 2020' is required in the area which is described in the schedule given below;

Whereas, there is emergency and circumstances do not permit the serving of notice in due time upon the public, this order is passed ex-parte under Sub-Section 2 of Section 144 of Cr.P.C.1973 and is directed to the public in general;

Now, therefore, I, Th. Kirankumar, District Magistrate, Imphal West District, Manipur in exercise of the powers conferred under Sub-Section 2 of Section 144 of Cr.P.C., 1973 do hereby prohibit the movement of any person outside their respective residences for **4(four)days from 4th August to 7th August, 2021;**

Further, this order shall not apply to the agencies of the Government Department(s) involved in enforcement of law and order and the curfew imposed shall not be applicable to the essential activities/services related to:

1. Vaccination (Persons related to vaccination drive and persons to be vaccinated to mention place of vaccination site when ask for)
2. COVID testing (Persons related to testing drive and persons to be tested to mention place of testing site when ask for)
3. Medical services(hospitals/clinics/pharmacies)
4. Water supply
5. Power supply
6. Police
7. Telecom/Internet services
8. Air Travel
9. Agriculture/Horticulture (no crowding and eating together shall be permitted at any location)
10. Garbage Clearance
11. Petrol Pumps
12. LPG Distributors
13. Goods Trucks
14. District Administration Officials/Staff managing COVID-19.
15. Print and Electronic Media
16. Post Office with minimal staff for urgent office work and delivery.
17. Banking and ATM services as per earlier order i.e. (a) banking services with limited staff on Monday, Wednesday and Friday from 10 am to 2:30 pm for urgent Government and non-government transactions only (b) ATM services including refilling of cash in ATMs.



18. Opening of Insurance offices for three days from 10 a.m. to 2: 30 p.m. like in the case of banks.
19. Veterinary and Animal Husbandry/Dairy-for collection and home delivery of milk and feeding of animals and birds in government farms.
20. e-Commerce delivery
21. Inclusion of vegetable /fish/meat and grocery items for home delivery in e-commerce allowed earlier.
22. Allowing home delivery of cooked food by authorised delivery staff.
23. CAF & PD-minimum staff/ personnel of CAF & PD and FCI.
24. Forest Department -continuation of tree plantations and also movement for feeding animals in the Zoo and National Park.
25. Officials and workers of road projects taken up by NHIDCL.
26. Officials and workers of road projects taken up by Asian Development Bank.
27. Officials and workers of Railway Projects in the State.

In case of emergencies and for persons who want to perform marriage, funeral services, Asti/Leihun, Sraddha/Sorat/Lanna Thouram, etc. within the scheduled area, applications may be made to the undersigned or to the Superintendent of Police, Imphal West District for permission with names of persons who shall attend in a Covid containment free area and they shall not carry out any programme/function until a written permission is obtained from authorities.


This Curfew order supersedes all earlier orders issued in this regard.
