O R D E R S

Imphal, the 11th January, 2022

No. DC(IW)/1/CON/361/02: Whereas, it has been reported that 28(twenty eight) residents at different localities in Imphal West District have been tested COVID-19 positive and in view of the impending threat of COVID-19 pandemic in the area, it has become expedient to issue containment measures to prevent the spread of the disease in the area;

Now, therefore, I, Th. Kirankumar, Deputy Commissioner of Imphal West District, Manipur, in exercise of the powers conferred upon me under Para 12 of "The Manipur Epidemic Diseases, COVID – 19 Regulations, 2020" and in pursuance of the advisory of the Director General of Health Services (EMR Division), Ministry of Health and Family Welfare, Government of India in regard to containment of COVID – 19, do hereby declare the following containment measures in the geographical area mentioned in the schedule with immediate effect:

- 1) Sealing of the geographical area.
- 2) Entry and exit of population from the containment area.
- 3) Closure of schools, offices, if any and banning public gathering of any type.
- 4) Banning vehicular movement in the area.
- 5) Initiating active surveillance of COVID – 19 cases.
- 6) Compulsory use of AarogyaSetu application by all the people staying/residing within the containment area.
