The Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation &

Whereas it appears to the Government of Gujarat that the land specified in the SHEDULE annexed hereto, is likely to be required to "The Mumbai-Ahmedabad National High Speed Rail Project" (hereinafter referred to as "The Required Body") for the public purpose for the purpose of construction of infrastructure project of "The Mumbai-Ahmedabad National High Speed Rail Project" (hereinafter referred to as "The public purpose Project")

8. Now whereas, the Government of Gujarat, Revenue Department has, in exercise of the powers conderred, by section-10(A) (inserted by section-3 of The Right to Fair Compensation and Tranparacy in Land Acquisition, Rehabilitation and Resettlement (Gujarat Amendment) Act, 2016 (Gujarat Act No.12 of 2016) of The Right to Fair Compensation and Tranparacy in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) (hereinafter referred to as "The Act") exempted, in public interest, by Notification No. AM-2017-143-M-LK-12-2017-1796-GH dated 10-11-2017 published in the extraordinary Gezette of Gujarat Government Dated 10-11-2017 the Below mentioned Scheduled area of land, of be acquird for the infrastructure project of "The Mumbai-Ahmedabad National High Speed Rail Project" from the application of the provisions of chapter II and III of The Act, and
9. Now whereas, in exercise of the powers, conferred by sub-section (1) of section-43 of The Act, Government of Gujarat has appointed, by Notification No. AM-2018-316-M-LK-1217-1796-GH dated 09-04-2018, Competent Authority & Special Land Acquisition Officer, Kheda as the Administrator of Rehabilitation and Resettlement in respect of the scheduled land to be acquired for construction of the captioned infrastucture project, and
10. Now whereas, in exercise of the powers, conferred by sub-section (1) of section-11 of "The Right to Fair compensation and Tranparacy in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) (hereinafter referred to as "The Act"), the Government of Gujarat, has notified, vide their Notification No. AM-2018-316-M-LK-1217-1796-GH dated 09-04-2018, that the said Schedule land is required for the public purpose specified here above,
11. And Whereas, the Government of Gujarat is satisfied after considering the report made by The District Collector, Kheda under sub-section (2) of section 15 of the Act, that the said land is needed to be acquired for "The public purpose project" specified in the Schedule hereto, and

12. Now therefore, in exercise of the power conferred by sub-section (1) of section-19 The Act, the Government of Gujarat hereby declares that the said Schedule lands is required for the public purpose specified in the Schedule hereto.
13. In exercise of the power conferred by clause (g) of section-3 of The Act, the Government of Gujarat hereby appoints, **Competent Authority & Specil Land Acquisition Officer, Kheda** to perform the function of a Collector, for all proceeding hereinafter to be carried out under The Act, in respect of the said Schedule lands.
14. The plans, of scheduled lands can be inspected at the office of The **Special Land Acquisition officer, Kheda.**


