(hereinafter reffered to as "the Public Purpose Project")

- Now whereas the Government of gujarat, revenue Department has, in exercise of the powers conferred, by section 10A [inserted by section 3 of the Right to Fair Compensation and transparency in Land Acquisition, Rehabilitation and Resettlement(Gujarat Amendment) (Act,2016 (Gujarat Act No. 12 of 2016)] of The right to Fair Compensation and transparency in Land Acquisition, Rehabilitation and Resettlement 2013 (30 of 2013) (hereinafter referred to as "The Act") exempted, in public interest, by Notification No. AM-2019-300-M-LK-1219-882-GH dated 29/05/2019 published in the Extraordinary Gazzette of Gujarat Government dated 29/05/2019 the below mentioned Scheduled area of land to be acquired for the infrastructure Project of The :Mumbai-Ahmedabad High Speed Rail Project" from the application of the provisions of the powers, II and III of The Act, and
- (9) Now whereas, in exercise of the powers, conferred by sub-section (1) of section 43 of The Act. The Government of Gujarat has appointed, by Notification No. AM-2019-491-M-LK-1219-882-GH dated 01/08/2019 The Special Land Acquisition Officer, Kheda as the Administrator of Rehabilitation and Resettlement in respect of the scheduled land to be acquired for construction of the captioned infrastructure project. and
- (10) Now wheres, in exercise of the powers conferred by sub-section (1) of section 11 of "Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) (hereinafter reffered to as the Act), the Government of Gujarat, has notified, vide their Notification No. AM-2019-491-M-LK-1219-882-GH dated 01/08/2019 that the said scheduled land is required for the public purpose specified here above.
- (11) And whereas, the Government of Gujarat is satisfied after considering the report made by the District Collector, Anand under sub-section (2) of section 15 of The Act, that the said land is needed to be acquired for "The Public Purpose Project" specified in the schedule hereto, and

- (12)Now therefore, in exercise of the powers conferred by sub-section (1) of section 19 of The Act. the Government of Gujarat hereby declares that the said scheduled lands is required for the public purpose specified in the schedule hereto.
- In exercise of the powers conferred by clause (g) of section 3 of the Act, the Government (13)of Gujarat hereby appoints, Competent Authority & Special Land Acquisition Officer, Kheda to perform the function of a Collector, for all proceeding hereinafter to be carried out under The Act, in respect of the said scheduled lands.
- The Plans of scheduled lands can be inspected at the Office of The Competent Authority & (14)Special Land Acquisition Officer, Kheda.
