

Tenders can be sent through Registered Post/ Speed Post or dropped in the Tender Box/Boxes at the Office of The Block Development Officer, Kadamtala R.D. Block, North Tripura within the last date for receipt of the tenders i.e. on 22-11-2018 (Thursday) up to 11.00 AM. The tender box will remain present in the Cash Section of this Block. Sealed tenders received shall be opened by the Block Development Officer, Kadamtala R.D. Block in presence of intending Bidder who may likely to be present at 12.00 Noon on 22-11-2018(Thursday) if possible.

The tender of the contractors who do not deposit the earnest money in the manner prescribed above will be summarily rejected.

**Terms and condition:-**

1. The Bidder should invariably be declared the name of his farm & location in the quotation paper along with other document. (i.e GST Registration, PAN card etc).
2. The Bidder should deposit all document in the sealed envelopment otherwise it treated as rejected.
3. The Bid should accompany the details of project to be implemented.
4. The Bidder should submit deposit at Call for an amount of Rs. 5,000/- (Rupees five Thousand) only from any recognized Bank (TGB/SBI/UBI/Syndicate) which may be forfeited for violation of terms & condition at any point of time.
5. **Rate should not cross the ceiling limit and should be quoted including Fitting fixing and carrying charges and all type of taxes.**
