In this connection, it is also to inform you that the Government in Revenue Department has examined your proposal along with the evaluation report of the Expert Group on Social Impact Assessment Study in connection with the above mentioned acquisition process and after examination of all the reports, the same has been recommended by the Government as per provision of U/S-8 (2) of the RFCTLARR Act, 2013.

3. In this regard, I am further directed to request you kindly to take necessary steps for wide publicity of the decision of the State Government to acquire land as per recommendation of the Expert Group in pursuance of the provision U/S- 8 (3) of the RFCTLARR Act, 2013. Thereafter, after making all formalities, proposal for issuing of Notification U/S-11 (1) of the new L. A. Act may be initiated.

4. This is for your kind information and taking necessary action on the issue.
