

Sealed tender for and on the behalf of the Chief Executive Officer (District Magistrate & Collector) North Tripura is here by invited to offer the rate(s) from the registered Chartered account for auditing of the District Rural Development Agency (DRDA) North Tripura District, Dharmanagar w.e.f 01.04.2018 to 31.03.2019. Tender may be drop in duly sealed cover either physically or through **registered post/courier up to 3.00 PM from 01.08.2019 to 16.08.2019 on all working day**, addressed to the project Director, DRDA, (1st floor of DTO Office, North Tripura, Digalbank, Dharmanagar). The envelope should be duly subscribed "Quotation for auditing different schematic Accounts of DRDA, North Tripura Distict, Dharmanagar for the period from 01.04.2018 to 31.04.2019." Last date & time of receiving tender is **3.00 pm on 16.08.2019**.


2. The terms and Conditions of tender are as follows:-

- (a) The tenderer may quote consolidated rate for the whole audit or may quote scheme wise rate as deem fit. But consolidated rate is best for selection & issuing work order.
- (b) The quoted rate shall have inclusive of GST as per admissible norms of the State and the Govt. of India.
- (c) Selected agency shall have to use its own means of conveyance etc. and no TA/DA will be paid by this office for any kind of journey including local transportation.
- (d) The rate should be quoted in both i.e. in figures and words.
- (e) The audit team shall have to complete the audit within fifteen days after issuance of appointment/work order.
- (f) The tenderer shall have to submit the attested copy of registration of his firm as issued by the C.A.I. New Delhi and also to quote the CAI No in their quotation.
- (g) The undersigned reserves the right to reject any/all tenders including the lowest tender without assigning any reasons as well as without prejudice to the Court of Law.
- (h) No price variation clause quoted in the tender shall be accepted.

- (i) Rate/amount quoted for consolidated or each scheme will be fixed and final.
- (j) The office shall not be responsible for late receipt of quotation or delay in postage/ courier.
- (k) In case of breach of contract/non-compliance by the selected farm within the prescribed period after getting the appointment order, penalty up to Rs.2000/- (Rupees two thousand only) shall be imposed on that farm.
- (l) The tender box will be **opened at 4.00 PM on 16.08.2019**, i. e the last date of receiving tenders, if possible. If it is not possible on the same date, next date will be notified accordingly.
- (m) The tendered may remain present during opening of tenders or may depute their authorized representative to remain present with a valid written consent from the firm.
- (n) **The minimum rate of audit of accounts of last financial year 2017-18 was received Rs.17,982/- (Rupees seventeen thousand nine hundred eighty two) only including GST.**
