NOTIFICATION

WHEREAS. Preliminary Notification **NO. F. 09 (03)-REV/ACQ/I/15** dated the 16-02-2019 under **Sub-Section 1 of Section 11** of "the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013", relating to the land/lands measuring 0.60 acre in Mouza **Bagabasha** of **Sanicherra** Tehsil was issued by the Government.

AND WHEREAS, the possession of **entire land measuring 0.60 acre** has not been taken over by the Government as, the land in question is no longer needed by the Requiring Department.

NOW, THEREFORE, in exercise of the power conferred by **Sub-Section (1) of Section 93** of "the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" the Government hereby withdraws from the acquisition of the said land/lands as described in the schedule below.
