TERMS & CONDITIONS

1. The rate should be typed and quoted both in figure and words. It should be quoted in Indian currency. The base value and GST will be mentioned in the tender.
2. The rate should be submitted in sealed cover duly superscript as '**RATE OF QUOTATION FOR PROCUREMENT OF HP COMPUTER**' to the O/o the SDM, Dharmanagar, North Tripura,
3. The payment will be made after the satisfactory supply of the items as per the specification detailed in the tender. The vehicle should be in good running condition and of the latest model.
4. The tender received after the aforesaid date & time shall be rejected. The undersigned will not be responsible for any postal delay.
5. The following self attested documents with current validity should be submitted along with the tender:- i) PAN No. ii) Trade license. iii) GST certificate. iv) Authorization of certificate v) Details regarding similar assignment done in the past/participation in such tender inquiry (if any). vii) Product catalogue /information brochure, viii) IT returns for the assessment year-2021-22.
6. Authentic documentary proof of exemption from Earnest Money.

7. The item should be supplied within 15 (fifteen) days from the date of issue of the supply order.
8. The tenderers should sign on all the tender documents.
9. In case of failure to supply the ordered items in full within the stipulated period, the earnest money shall be forfeited without further correspondence. The Govt. will not consider any enhancement of rate within the validity period of contract except imposition of any levy or increase in existing levy.
10. The legal jurisdiction is restricted to the District Magistrate & Collector, North Tripura, Dharmanagar.
11. The quality, guarantee period /for the goods should be clearly mentioned. The successful bidder shall have to install the item at the delivery point for which no changes shall be claimed. After acceptance of rate, if any bidder refuses to carry out the terms & conditions of the tender/ not interested to do the work his /her security money will be forfeited.
12. Quotations should be supported by the relevant valid GSTIN certificate/documents of the vehicle etc.
13. Quotationers or their representative may remain present at the time of opening of tenders/quotations.
14. GST & Income Tax as per rate will be deducted from as applicable.
15. The undersigned reserved the right to accept or reject any or all quotations including the lowest rate holder without assigning any reason.
