**ORDER**

**Dated Nongpoh the 25<sup>th</sup> March 2020**

As per Guidelines of the Ministry of Home Affairs vide Order No.40-3/2020-DM-I(A), dated 24<sup>th</sup> March 2020, the following measures are put in place.

1. The Executive Magistrates and Block Development Officers have been notified as Incident Commanders and their areas of operation for the overall implementation of the measures are as per details below:

2. Food grains will be lifted from FCI, Khanapara by all the 17 wholesalers in the district for the quota of April 2020 on or before the 30<sup>th</sup> March 2020 and all food grains have to be delivered to all the Fair Price Shop Dealers falling under their respective jurisdiction and distribute within 8<sup>th</sup> April 2020. All Incident Commanders shall coordinate with the Supply Branch to ensure that the food grains are lifted on time and the same to reach all the Fair Price Shop Dealers.
3. Curfew Pass will be given to all the wholesalers with proper routes to collect essential commodities from FCI and to reach to all the Fair Price Shop Dealers at every village.
4. The identified banks will be asked to open so that the wholesalers can complete the process of payment.
5. Timing of distribution of food grains will be communicated through the Rangbah Shnong, preferably between 7 A.M to 3 P.M.
6. Fair Price Shop Dealers will distribute ration to each household for 1 month.
7. Only 1 representative from each household will be allowed to collect the ration with proper maintaining of social distancing from each other, i.e. 1-1.5 m. Not more than 20 people shall be allowed in a queue. In case of more than 20 households, the distribution shall be done in equal batches.



8. The respective Rangbah Shnong will ensure proper register of distribution and house listing may be worked out along with the Fair Price Shop Dealers.
9. The Deputy Director of Supply, DC's Office will also work out in advance the ration for April 2020 immediately.
10. For those unlisted households/floating population like labourers and new households which are not included in the SECC list, the respective Rangbah Shnong will be requested to provide the information to the Incident Commanders through the Fair Price Shop Dealers by the 28<sup>th</sup> March 2020.
