ORDER

In pursuance to the order from Home (Political) Department, Government of Meghalaya vide No.POL.75/2020/Ptl/86, dated 13th April 2021 and No.POL.75/2020/Ptl/88, dated 19th April 2021, the revised restrictions on permitted activities are as follows.

1. Entry of tourists from outside the State shall not be permitted from 23rd April 2021 up to 7th May 2021.
2. Maximum number of persons allowed in places of worship is decreased to 50% of the seating capacity.
3. Maximum number of persons allowed during any Religious/Social/Private gatherings is decreased to 50% of the seating capacity.
4. For outdoor sports, spectators are permitted up to 50% of the seating capacity.
5. Cinema hall to operate at 50% of the seating capacity.
6. Any other program of an urgent and unavoidable nature may be considered only upon application to the office of the Deputy Commissioner, Ri Bhoi District.
7. Hotels and restaurants will open at 50% seating capacity and to close by 9 P.M. Any violation and non-compliance to SOPs will make the establishment liable for closure. People are advised to avail home delivery and takeaway service.
8. Shops and markets are allowed to open and to close by 9 P.M. However, non-compliance to protocols including maintenance of distancing, mask-wearing and hand hygiene will result in closure of the establishment. Street vendors and hawkers will comply assiduously to COVID-19 safety protocols and social distancing is to be properly maintained. All Restaurants/Cafes/Food outlets along the National Highway should erect barricades and safety barriers in front of their shops to maintain physical distancing. All Market Covid-19 Management Committees to ensure adherence to Covid protocols issued by the Department of Health & Family Welfare, Government of Meghalaya vide No.Health.140/2020/10, dated 19th June 2020.
