ORDER

(No. DCRB(CN)/COVID-19/1/2020/Pt.I/113,

Dated, Nongpoh the 27th April, 2021)

Whereas, report has been received from the District Medical and Health Officer, Ri Bhoi District that COVID-19 Positive case was detected at **Sajer village, Ri Bhoi District** and the patient was died in Hospital to day the 27.04.2021 and which requires contact tracing, testing and isolation in the interest of health of general public and to prevent against any possible spread of COVID-19 virus in the said area and the District as well.

Whereas, it has become necessary to contain the disease within a defined geographic areas by early detection, breaking the chain of transmissions and thus preventing its spread to new areas. And also as to enable the Health & Family Welfare Department to trace the contacts and active search for cases through physical house to house surveillance by special teams.

Now, therefore, I Smti. R. M. Kurbah, IAS, District Magistrate, Ri Bhoi District, Nongpoh, in exercise of the powers conferred upon me under section 144 Cr.P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 and Amendments and also as per Recommendation by the District Medical and Health Officer, Ri Bhoi District, Nongpoh I, **do hereby 'DECLARED' the following area as a 'MICRO-CONTAINMENT ZONE' and also prohibit as follows w.e.f 27th April, 2021 to 2nd May, 2021.**

1. AREA UNDER 'MICRO-CONTAINMENT ZONE':

House of Smti Eugenea Rymbai, Sajer village, Ri Bhoi District

2. PROHIBITION IN THE AREA DECLARED AS 'CONTAINMENT ZONE':

- No person shall be allowed to move into the containment area and inhabitants within this area shall not move out.
- All the inhabitants within the Containment area shall strictly remain inside their home,

3. GENERAL INSTRUCTION:

- Strict maintenance of social distancing of atleast 6 feet
- Aadvocacy on hand hygiene, respiratory hygiene environmental sanitation and wearing masks/face-cover.

Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and IPC.

In view of the urgency of the matter, this Order has been made ex parte.
