ORDER

No. DCRB(CN)/COVID-19/1/2020/Pt.I/319,

Dated, Nongpoh the 8th July, 2021.

Whereas, in supersession of this office earlier order No. DCRB(CN)/COVID-19/1/2020/Pt.I/317, Dated, Nongpoh the 8th July, 2021 and as per report received from the District Medical and Health Officer, Ri Bhoi District that COVID-19) Positive cases has been detected in **Pahamsohthri Village**, Ri Bhoi District.

Whereas, contact tracing, testing and isolation in the interest of health of general public is necessary to prevent against any possible spread of COVID-19 virus in the said area and the District as well.

Whereas, it has become necessary to contain the disease within a defined geographic areas by early detection, breaking the chain of transmissions and thus preventing its spread to new areas. And also as to enable the Health & Family Welfare Department to trace the contacts and active search for cases through physical house to house surveillance by special teams.

Now, therefore, I Smti. R. M. Kurbah, IAS, District Magistrate, Ri Bhoi District, Nongpoh, in exercise of the powers conferred upon me under section 144 Cr.P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 and Amendments and also as per Recommendation by the District Medical and Health Officer, Ri Bhoi District, Nongpoh I, do hereby **DECLARED** the following area/households as a 'MICRO-CONTAINMENT ZONE' and also prohibit as follows **w.e.f 6:00P.M of 8th July, 2021 - 6:00PM of 18th July, 2021** to enable the Medical Team to carry on the contact tracing.

1. AREA UNDER 'MICRO-CONTAINMENT/CONTAINMENT ZONE':

- i. House of Blibon Lyngdoh, Pahamsohthri Village.
- ii. House of Elphi Lyngdoh, Pahamsohthri Village.
- iii. House of Pynshai Lyngdoh, Pahamsohthri Village.
- iv. House of Hunlin Syngkli, Pahamsohthri Village.
- v. House Jemeous Chyne, Pahamsohthri Village.
- vi. House of Sibina Lyngdoh, Pahamsohthri Village.
- vii. House of Darilin Lapang, Pahamsohthri Village.
- viii. House of Marshall Syngkli, Pahamsohthri Village.
- ix. House of Kmenson Syngkli, Pahamsohthri Village.
- x. House of Pynsuk Matlai, Pahamsohthri Village.
- xi. House of Phrangngi Lyngdoh, Pahamsohthri Village.
- xii. House of Ripplelang Kharkongor, Pahamsohthri Village.
- xiii. House of Rina Rummnong, Pahamsohthri Village.
- xiv. House of Anthony Kharthangmaw, Pahamsohthri Village.
- xv. House of B. Malieh, Pahamsohthri Village.
- xvi. House of Shaining Kharkamni, Pahamsohthri Village.

2. PROHIBITION IN THE AREA DECLARED AS 'MICRO- CONTAINMENT/CONTAINMENT ZONE':

- No person shall be allowed to move into the containment area and inhabitants within this area shall not move out.
- All the inhabitants within the Containment area shall strictly remain inside their home.

3. GENERAL INSTRUCTION:

- Strict maintenance of social distancing of atleast 6 feet
- Advocacy on hand hygiene, respiratory hygiene environmental sanitation and wearing masks/face-cover.

Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and IPC.

In view of the urgency of the matter, this Order has been made ex parte.
