Daily report on defacement of public property should also be submitted by the team in the prescribed format. These team should report to duty before the concerned ROs each day and chart out their daily action plan along with, There should be proper co-ordination between the Anti defacement squad and Video Surveillance Team of each LAC. The ROs of the respective LACs are personally responsible for the performance of the Defacement squad of their

LAC.In case of requirement of additional team all ROs can take necessary steps to form additional team as per actual requirement.
